President Rick Anderson's Thoughts

Like most Augusts, the expected "lake level drop" is in progress. The lake is about five inches under the "Top of Dam" level. Think that's low enough to talk "second pump"? Maybe. Who believes all the bluegill stocked last year have helped lake clarity? The believers; this believer has never seen the lake clarity this good this long into the summer. It's well over a foot. The lake bottom still has much filamentous algae.

Are you up to speed on the Starke County "Constellation of Starke" effort? 2019 Property Owners meetings have had much focus on this; the August 24 meeting will include more. Indiana has recognized the benefits of granting counties and communities financial incentives to improve existing assets; a reward for vision and efforts. Can Property Owners help and participate? This is included in our BLPOA By-laws: 4. Establish an effective relationship with local and state officials, agencies and organizations. As part of the Stellar Community effort, Starke County has identified over \$14,000,000 in potential project initiatives targeted at community improvement. As a demonstration of support, your BLPOA Board will discuss and consider committing \$40,000 over the next 4 years, contingent on winning the Stellar grant. Input and commentary from our membership will certainly be appreciated at our August 24 meeting. Financial commitments need careful considerations; however, financial commitment by the people of a community improve the chances of winning. The "Stellar" designation is awarded based on undeveloped project summaries, renderings, and rough estimates of concepts. Why undeveloped? Because good project development takes funding and good project development requires time. That is why the implementation phase of "Stellar" is four years with funded planning and implementation. This process affords time for much community input. Of the "Starke Identified" \$14,000,000 in projects, \$5,000,000 is targeted at Bass Lake and the Beach. Take a ride to Culver's Maxinkuckee Beach. Why can't our beach be as good or better than that? One thing for sure, if Starke wins, our BLPOA should provide input into determining the future of our beach. I for one would like county approval to drill a test well with the intent of installing a second lake pump at the beach. We will review many of the identified projects at our meeting before voting on possible funding participation. Give some thought to: "Bass Lake Public Beach Future."

What else: Our grant request for glacial stone in front of existing sea wall has been approved at a 63% of requested funding level - details will be forthcoming to the 44 property owners who applied for the grant. All American Game Jackpot: approaching \$300K. Stay Safe and Healthy, Rick

Constellation of Starke - Stellar Community Improvements

Starke County is one of four finalists for the State of Indiana Stellar Communities Designation Program. The Stellar Communities Program is a multi-year, multimillion dollar investment initiative led by Indiana's Office of Community and Rural Affairs. This is a significant event for our lake community; if Starke County is selected this year (or in a future year) over \$5 million will be invested in and around Bass Lake! A new beach house will be constructed at the Bass Lake Beach. This new building will include a café/concessions, a Great Room that will be a place for people to meet, offices for beach personnel, and restrooms. There will be a water park with a floatable obstacle course. Future projects may include an updated picnic area, a new shelter, a launching area for kayak and canoe rental, paved parking lots and shoreline restoration.

There is also an exciting roadway project that will increase connectivity to shopping, dining and recreational activities for golf carts and bikes. There will be a new trailhead at the intersection of CR 450 E and CR 210. This will include restrooms, signage, parking for people who are using the Erie Trail for biking or the public launch. If you are interested in learning more, please contact BLPOA Board members who are involved in the effort, Rik Ritzler, AJ Gappa or Gayle Smith. Note that a decision will be made by year-end. If the county is not selected this year, the county will reapply next year.

This is the Bass Lake Pump which pumps 1.6 million gallons of water into our lake every day from an underground aquifer.

The Bass Lake Pump—Located on the east side of the lake by The Bass Lake Pub and Ristorante and Cranberry Lane, is our lake pump. It was installed in 1964 when the lake level was at an all-time low; 36 inches below the "top of the damn." This pump is an essential tool to maintain the level of our shallow lake. It is maintained and operated by the Bass Lake Conservancy District (BLDC). Thank you to the BLCD for providing this service to our lake! Put simply, the pump runs most of the summer and each day it pumps 1.6 million gallons of new water into our lake from an underground aquifer. The BLPOA has begun discussions with the BLCD and the County about the feasibility of a second pump. Lake and River Enhancement Grant (LARE) - In January your BLPOA submitted a grant request to the Indiana DNR for a grant to help pay for glacial stone refacing of many of the concrete seawalls in our lake. Our project was approved! We will receive \$35,000 to fund 50% of the cost of our glacial stone seawall projects. We will send detailed next steps to the 44 property owners who applied for the grant next week. Projects will begin this fall and can also occur in 2020 and 2021. Questions? Lake Michigan Temps Plummet—In late July the large waves in Lake Michigan caused the water temperatures around New Buffalo to drop significantly. The water got so cold that hypothermia and cold shock could occur in a matter of minutes. The large waves and strong northerly winds caused "upwelling" where the warm lake water was pushed away from the shore and the much colder water beneath the surface replaced it. According to the Great Lakes Observing System website, the water temperature off the coast of Stevensville dropped 25 degrees in less than 24 hours. At 3 a.m. July 22, the lake temperature was 75 degrees. By midnight the water was down to 50 degrees. Crazy!

Bass Lake History — The White Family

Freddie, Edo, Clarence, Vada and Fred M. White are shown in this photo dated about 1910. Fred and Emma White's farm was located at the former Bass Lake Golf Course. The White's started their homestead in 1889 by clearing 33 acres. They eventually expanded the farm to 217 acres and 15 lakeside lots before selling to the golf course developers in 1927.

Note the huge stack of straw left by recent threshing and the team of oxen. Many farmers used oxen before tractors because of their strength and gentle nature.
