**Avoid Lawn Fertilizers with Phosphorus**—The chemicals you use on your lawn impact the quality of our lake water because the chemicals will flow into the lake. Follow this basic guideline to help us keep our lake waters healthy. If you choose to use fertilizer, use a slow-release nitrogen fertilizer. A fertilizer with no phosphorus means that the middle number on the fertilizer package listing the nutrient ratio: (nitrogen : phosphorus : potassium) is 0.

### Bass Lake History—Ora Depot

In 1882, the Chicago & Atlantic Railroad built its railroad line through Starke County. It passed through Lomax, North Judson, Al-dine, Bass Station and Ora. Later this railroad was organized as the Erie.

The photo probably dates from the 1920's, based on several Model A's in the background. One sign reads "Western Union Telegraph & Cable Office". Another reads "Erie Rail Road". A sign on the building to the far right says "Pickles". Note the double tracks and the spur running to the grain elevator.

Our best guess is that the gentleman on the left is the ticket master, while the one on the right is a railroad agent.

**Why is there Foam on the Water?** - Foam sometimes appears on Bass Lake. It accumulates against logs, and along the shores. The presence of foam is not necessarily an indicator that there is pollution in the water. Foam is most often the result of natural processes, not environmental pollution and is usually harmless. Foam occurs naturally when the physical characteristics of the water is altered by the presence of organic material in the water. It only takes a small amount of fatty acid being released from decaying leaves and other organic matter to produce a large amount of foam. The foam is usually about 1% of what you see. **Using Our Trails During COVID-19** —Note that our lake community offers beautiful options for outdoor walking and biking. The nearby Erie Trail is our 9.2-mile paved bike trail. According to Prairie Trail volunteer Kathy Lucas, "We have ridden both directions recently, to the Trail's western end at Main Street in North Judson and to its southeasterly terminus at U.S. 35. Also, we can see the Trail from our windows. We have noticed more users, but they appear to be maintaining social distancing in conformance with state and federal guidelines. Most groups seem to consist of a couple or parents and children. The paved part is 10' wide, so even when passing another user, an appropriate distance can be maintained. People go single file when passing, and some people are wearing masks as well. Health officials encourage fresh air and exercise, and the Trail offers a way to get both." Also, new brochures with maps are in the mailboxes on the Trail at U.S. 35 and CR 250 at the rest park.
