# President Rick Anderson's Thoughts

On February 1 the Bass Lake winter really began. Lake level was minus 17 inches, just like on January 1. I was reminded of winter 1971. 1971 was the only year I left my Shore Station in the lake. Well, not in the lake, rather on the sandy shore far from water's edge. I was surprised in the spring that two of the blocks I wisely placed under the station's feet had been knocked out by the ice. Bass Lake water can rise quickly or not. I wonder about the 2021 level. Although January had almost 3 inches of rainfall the level did not seem to come up. Average rainfall for February, March and April over the past 20 years has been a combined total of 10 inches. Therefore, if 2021 turns out to be average, the lake level on May 1 might be minus 7 inches. Of course, our pump should be pumping. That could help. Maybe more pumping would help more.

The February 6 Property Owners' meeting: The entire Board and 15 property owners were present. First, previous minutes approved, then AJ Gappa reported a December financial balance of \$211,827.06. The approved 2021 Annual Letter and Membership Form will go out by email mid February. All members will receive them by US mail at the end of March. Ron Vendl, Mary Topelian and Kathy Laiter were thanked for their work on the Directory. Building party rentals will be a meeting agenda item until they resume. Terry Chmiel reported the boating class will be June 5 at Bass Lake. Social Events Planned: The July 17 Bike Ride, the October 23 Soup Social and the December 4 Christmas Bizarre are anticipated. Ti Jones talked about organizing a "Century Bike Ride" the week after Labor Day - it might be coordinated with the Park Board. Neighborhood Watch reported on activities. The glacial stone project was reviewed and a possible farmers' market was discussed. The marina may get a mural painted by artist Anthony Brooks. Our camera system may need an upgrade; A tech savvy property owner offered to look over our system and offer advice. The Solar Farm and rezoning will continue to be on the Commissioner's meeting agenda; their next meeting is scheduled for February 15. If you are concerned about speeding around the lake, please report your concern to the Sheriff's Office. The BLPOA Board still has a vacant Director position. Being on the BLPOA Board is a great opportunity to meet your fellow property owners and become involved in lake community activities. Contact a Board member to learn more.

Both Jane and I were impressed with Starke County's COVID-19 vaccination program. It was well organized and professionally run; the backbone of the program was the volunteers. 

Solar System Model—Last year, Jessica Martinović of the Starke County Community Foundation obtained a \$100,000 grant from the Lilly Endowment's GIFT VII program for arts and cultural opportunities as pursued by the Foundation and Constellation of Starke. Included was \$25,000 dedicated to the In-Scale Model of Our Solar System. The project envisions placement of exhibits for the Sun, planets and other heavenly bodies in our solar system along the Erie Trail sized and distanced to scale. A workgroup was formed to help implement the grant with Territorial Engineering providing design. The Sun exhibit would be near the Main Street, North Judson Trailhead with other exhibits to the southeast. As an example, the Neptune exhibit would be placed on the Erie Trail just west of US 35. In ecology, we call this a food chain, or a food web. Fantastic Free Lake Webinars - The Midwest Glacial Lakes Partnership recently announced its 2021 Lake Conservation Webinars. These free webinars address a diversity of lake and fish habitat management issues from wake boats to watersheds, from Ogaa (Walleye) management to social marketing, and from algae research to

Bass Lake Conservancy District (BLCD) - Precipitation for January was <u>2.78</u> inches. Directors Russ Blais and Jerry Broadstreet have submitted the requisite information and fees for the 2021 LARE (Lake & River Enhancement) Grant. The BLCD directs LARE endowments toward lake weed maintenance. If approved by the Indiana DNR, the BLCD is expected to receive approximately \$5,000 in funding dollars. The BLCD expects to receive approval status – including any funding dollars – late March or early April. NOTE: the state does not disperse any funds until work is performed.

Last year the BLCD received \$6,280.00 in LARE funding. \$5,000.00 was for weed maintenance and \$1,280.00 for two weed studies as required by the DNR before any treatments were approved. The spring study identified approximately 456 acres of the invasive Milfoil. However only approximately 157 acres were approved for treatment. Not including the LARE dollars, the BLCD paid out an additional \$61,258.40 for Milfoil and shoreline Phragmites treatments.
