President Rick Anderson's Thoughts

Three inches of fresh melting April snow helped raise lake level to the minus 13 inches. Minus 13 inches in early April is not good. What good is: COVID-19 is ending and traditional Bass Lake handshakes and hugs are back. Our taverns and restaurants have survived; stop in and leave a good tip. BLPOA rentals are resuming and our lake pump is pumping. I'm reminded of 1964, that year our lake had dropped to minus 36. That year people still had fun. They didn't worry about shallow water, wherever there was water there was deep water. What was a concern were the beaches that stretched hundreds of feet to waters edge. Consequently, the BLPOA installed our pump.

April 3 BLPOA meeting: A computer crash kept us from approving last month's minutes. The February Treasurer's report was approved. 2020 donations to the Fire Department, Food Pantry, Neighborhood Watch and the Social Committees were reviewed. Property Owners are encouraged to attend the Conservancy District meetings. "Bass Lake Loops" is being planned for September 11. The DNR Boating Class was discussed and is still in the planning stages for June 5. Our Healthy Shoreline project is "on track". The Conservancy District has contracted for a weed survey and has applied for a grant. As usual, weed treatment will need DNR approval. Individual property owners can still treat 625 square feet in front of their property. I have some Hydrothol Granular left from last year which I obtained from Aquatic Control in Valparaiso. To help with communication and to possibly help with issues if they arise. A BLPOA "Irrigation Pump Advisory Committee" was established . At our May meeting, our bylaws require the establishment of an Audit & Budget Committee and a Nominating Committee to help with our July annual election. The board remains one Director short and property owners are encouraged to consider getting more involved with our organization.

Despite a low lake level many piers are already out in the lake. Boat lifts and boats seem to be taking a "wait and see" approach. "Wait and see" is about rainfall and the cyclical history of Bass Lake's water level. In the meantime, engineering work continues on the solar farm. Irrigation water redirection remains part of total project engineering work and initial DNR comments have been positive. More specifics are needed for all approvals. Construction work awaits. Stay tuned; hopefully 2022 will see an operational Starke County Solar Farm which will include "used to be" irrigation water repurposed and flowing once again. At the "V", check out the



Bass Lake Country Club Elijah and Sally Wood purchased 78 acres, including what became known as Cranberry Point, on Bass Lake's east side in 1861. Around 1890, Elijah's daughter Nancy and her husband, William Ayers, permitted an association of property owners to build the Bass Lake Country Club at Cranberry Point. It was the scene of many social events, including family reunions.

In 1929, the Indianapolis Naval Reserves Corps rented Cranberry Point, including the club house, from the Ayres family. Their Naval Academy for

boys aged 12 to 18, known as Camp Gridley, was then moved from Indianapolis up to Bass Lake. In 1933, Ced White took over the lease and continued to run Camp Gridley as a boy's camp. When World War II came along, Ced White enlisted in the Army and the camp sat idle for several years. Eventually, the clubhouse was dismantled for its lumber and reused elsewhere. After the war, Ced White reopened the camp as a "Dude Ranch" housing the horses in a barn there on Cranberry Point. After a few years, Ced relocated his Dude Ranch to a farm east on Hwy 10. Invasive Privet Plant— Privet is a common plant used in landscaping and it is spreading into native woodlands as an invasive plant. It forms thickets that prevents the growth of native plants. There are many good alternatives to privet which are friendlier to the environment. There are several species of viburnums that would work well. They have flowers and berries that provide food for wildlife. Red osier dogwood is another shrub that can be used. Local Resident Marilyn Swanson - We have a treasure living at Cranberry Point $\sim 93\ 1/2$ year old Marilyn Swanson. Her family was one of the first two that settled at Bass Lake in the 1800s. They owned much of the east shore of the lake from Sportyz to Cranberry Lane. She remembers 1964 when our lake water level was at an all-time low. Her family played baseball games in the sandy area of the lake when the water receded. She is an advocate for taking advantage of the current opportunity add additional pumps to our lake water level challenge. The wells currently used to irrigate her family farm crops will be diverted to the lake in a proposed strategy to add additional pumps to the lake.

Why would the company that our community is working with, Global Energy Generation, be willing to pay for the engineering and

construction work to bring irrigation water to our lake? This helps our community and builds good relations with the residents near the proposed solar farm. Marilyn is also passionate about The Bass Lake Cemetery. Stay tuned for more!

DNR Fish Stocking Plan—Per our DNR "fish guy" Tom Bacula, he's confident that Bass Lake will be stocked with Walleye, probably at a historical level; 600 Walleye fry per acre. That's a lot of tiny Walleye! Fish stocking is at Bass Lake is expected later this month or in early May.

Bass Lake Conservancy District (BLCD) - Rainfall for February was 2.41 inches. Total rainfall for 2021 is 6.73 inches. The lake pump is currently pumping 1.4 million gallons a day. The DNR has temporarily approved 240 acres for invasive vegetation treatment. The DNR will perform lake inspections late April/early May to determine how many actual acres (if any) can be treated. Our next scheduled

meeting is Monday, May 10, 2021 at 6:00 p.m. CST – BLPOA building. Face masks and social distancing will remain in effect.
