#### VII. Building Maintenance

Rick Anderson stated of our 8 cameras 3 are not working. The estimated cost would be about \$600 for a new set and at this time we are waiting at least one more month.

Rick shared we have received three quotes on removing some trees as well as trimming back the tree line along the parking side of the building.

Rick advised that our building is no longer being considered for a possible mural since there are visibility issues. The building on the corner by the Marina is now the possible location.

#### VIII. Neighborhood Watch

Russ Blais advised that Ron Vendl is out of town and that the deputy did not attend the last meeting. He highlighted some activity that took place around the lake during the last month. The next meeting is scheduled for April 12 at 6:30 PM at the BLPOA building.

# IX. Bass Lake Conservancy District

Russ Blais and Jerry Broadstreet gave updates. They shared that the grant from the State this year will again be \$5,000 for weed control. The BLCD will be selecting a contractor within a few weeks and the BLCD will pay the difference from grant to total cost of spraying weeds. The request this year is for 300 acres. Debbie King is expected to survey the lake around the second week of April. The contractor and BLCD will ride along during the survey.

It was suggested the group put a proposal together as to how many people, how often they meet and any other information needed and to submit to Rich Linkus. A cost will be determined at that time.
