The new Trail Head Project is scheduled to be completed this year. There will be a parking area and bathroom facility.

VIII. Building Maintenance

Ron Vendl stated that now that the weather is warming up he would work on repairing the flagpole. It was noted that some of the new patch was coming up in the back of the parking lot and needs repair.

Rick Anderson noted that now 6 of the 8 cameras are working and purchasing a new system is on hold. He further stated that we need to look at hiring an exterminator for the building and restart the service. Any referrals please send to Ron or Rick.

Member asked about property assessment increase. It was noted that it was for the Kankakee River Basin to clean up the area and river. The entire county had their taxes raised.
