
President Rick Anderson's Thoughts

August lost 3 inches of lake level dropping it to –7 inches by September 1, as compared to –11 on September 1 last year. Lake clarity is around 2.1 feet. The August BLPOA meeting: the Republican and Democratic candidates for Starke County Sheriff, Jack Rosa and Kelly Fisher addressed the membership and answered questions. I appreciated both candidates telling us about themselves. It is good to know our sheriff. Along with other candidates, they will probably both be speaking at the Starke County Candidates' Night on October 4. It will be held at the Knox Community Center. Minutes, the Treasurer's Report, committee reports and 2022/2023 assignments were reviewed. Stefanie Neal will head the **October 15 Soup Social** with help from Shirley Grajewski. Mary Topelian will share insight's from previous events. During the maintenance reports, Aileen Collura pointed out the aging Green Room ceiling tiles which will be addressed. Ron Vendl and Russ Blais will head up the 2023 Directory Committee. Tom Busch gave a Park Board beach update: Tracy Williams is the new Park Superintendent. There will be a "Welcome to Bass Lake" sign kick-off meeting on September 17 at 9:00 a.m. at the BLPOA. I will meet with Solar Farm personnel and will have a progress report for our year-end October 15 BLPOA meeting.

More on the "Welcome to Bass Lake" signs. When we purchased the Toto Road/625 E. sign and the sign near the Bass Lake Pub, discussion took place on a new sign at the new three-way stop. This location previously had a BLPOA welcome sign. The committee will decide if and what signage would be appropriate for this location. A "Welcome to Bass Lake" sign would be welcoming when pulling up to the stop from the west (600 South.) When you pull up from the east, it is different. You are already at the lake. Turn right and you will continue around the lake on S. CR 210. Go straight and you are on your way to Nick and Linda's Fruit Stand, Bailey's, North Judson, Knox or Winamac. You probably would not be headed to Culver. The Pub sign is really the "Welcome to Bass Lake" sign when arriving from the Culver direction. It should probably be double-sided. Perhaps, "Come Back Soon" on it's west side makes sense. Maybe there should be a new welcome sign on SR 10 where it meets the lake. I have heard several opinions on this; you may have one too. Any property

owner who would like to participate at the meeting is welcome. Put October 15 at 9:00 a.m. at the BLPOA Building on your calendar. More on the second pump: I did meet with Ed Baptista from the Solar Farm and indeed there will be a pro-

On August 29 there was a storm that flipped boats and damaged trees, piers and homes on the north end of the lake. There was also a widespread power outage.

Bass Lake Conservancy District - August rainfall totaled 3.18 inches for a YTD total of 24.06 inches. The lake pump added 34 million gallons for a YTD total of 195.40 million gallons. The recent storm and microburst caused a large power outage. In addition to our diesel generator that serves the main lift station (CR 210 & 450), our three new Generac generators saw duty as well. Each automatically ran until service was restored (approximately 9 hours). The BLCD is looking into budgeting for additional generators in 2023. Submitted by Larry Collura—BLCD Vice-Chair

Klopot Photo Studio—A photo taken in the 1910's shows two ladies with their children in a horse drawn buggy. They have stopped in front of Klopot's Photo Studio at Bass Lake. In those days, Sigmund Klopot and his wife, Clara, had a studio at North Judson, Bass Lake and Knox. The studio at Bass Lake was usually only open on weekends in the summer. It was located at the north end of the lake in Winona.



The road only went around part of the lake then and was not yet paved. This particular picture was a photo postcard. Postcards were very popular at that time and only cost one cent to

mail. Photographers used heavy weight photo paper to make personalized post cards like this one.
