PRESIDENT RICK ANDERSON'S THOUGHTS...

On October 1st, I measured lake level at minus 9 inches; last October 1st, I measured it at minus 11. September's and early October's weather have been warm without much rain. This has resulted in a falling lake level and trees holding onto their green leaves. Once we get a good first frost, as they do every year, the leaves will change colors and start falling. The annual Bass Lake leaf burning season will then begin. Low rainfall is good for leaf burning; however, even with the pump running, Bass Lake needs rain to hold level. So what about a second pump? Doral is having discussions with their consultants on the final well location and all required permits will need to be obtained. Meanwhile, our 1964 pump continues to pump. Between that pump, snow, spring rains and maybe a second pump, hopefully Bass Lake will be full by the start of the 2023 season. Our pump has a history of helping to bring back level in the off season.

At our October 15th Property Owners meeting a 2nd pump discussion took place. As I explained above, Doral is actively working on the 2nd pump project with their consultants. We also did a yearend wrap up and talked about planning for 2023. Several new welcome to Bass Lake signs were approved pending quotes and location approval by the Highway Department. New Green Room ceiling tiles were approved. Many members helped with Soup Social set-up after the meeting. As the 2022 season winds down, its "STUFF COMING OUT TIME" again. Much "stuff" is already out, and much "stuff" is still in. Why not take a walk and see for yourself. New structures & new landscaping can be seen. It is also "Falltastic" time". The Halloween decorations are out. Decorations featuring ghosts, goblins, pumpkins, witches and even skeletons all indicate its almost "Soup Social Time". The annual Soup Social started at 4:00 and wrap up about 6:00 pm; it was a great event with Soup & Falltastic winners.

A little more on the existing lake pump and the proposed second pump. In 1964, with lake down about 36 inches, our lake pump became reality. Questions were asked: Will a pump bring back lake level? Where should the well/pump be installed and what effect will its operation would have on the lake and the aquifers? Interestingly, back then, more locations were available for a lake pump and time was taken to evaluate potential pump sites. Several test wells were drilled and the current pump location was determined to be the best water aquifer source. So what about the location chosen for the second pump? It was not the first choice in 1964 and the 2022 test well again indicated its location might not produce as much water as the existing pump does. Now, just like in 1964, the only way to really know for sure is to put in the pump and find out. That would also be the only real way to know if problems with nearby wells would develop. Any nearby well issues would need resolution. So, there is a question. Install at the test well site or somewhere else. Time, as it always does, will tell. What about the Great American Game at the VFW? It is still going strong with the jackpot at \$79,200; good luck. *Stay safe and healthy, Rick*

A postcard photo dated 1940 shows the business district at the south end of Bass Lake. US Highway 35 was fairly new and ran directly by the lake back then. It had only been designated a federal highway since 1934 and was still shared with IN 29. There were two more filling stations across the road, as well as a stop for Indiana Motor Bus. An amusement park, ballroom, skating rink and hotel were just to the west.

This had been a busy intersection dating back to the 1890's, when the Erie Railroad operated a spur line up to a long pier that extended into the lake at this end. Stem boats picked up tourists and their baggage and delivered them around the lake to numerous hotels. *Submitted by: Ron Vendl, photo from Starke County Historical Society*
