Ron Vendl & Kathy Laiter said they intend to be on the ballot. Mary & Rick will also be on the ballot probably along with AJ & Jan.

- To be one the ballot, you must have a petition submitted by Midnight June 1st.
- Camera tests are being reviewed and more testing is anticipated to determine if illegal hook ups exist.
- $\circ$   $\;$  A LARE Grant has been obtained to treat the milfoil weeds in the lake.

#### **Neighbor Hood Watch - Ron Vendl**

- The first yearly meeting was Wednesday, April 9th.
- There was an auto theft reported civil matter. An elderly gentleman passed away and one of his kin ended up with the car that was supposed to go to another family member.

- A two motorcycle accident on April 12 North Judson man died at the scene and Knox man was airlifted to South Bend Memorial and listed in critical condition. Both were not wearing helmets and alcohol and speed are believed to be factors in the accident.
