#### 12. Healthy Lakes Rick Anderson

- On Tuesday, May 30th. IU came up from Bloomington. We are now part of the Clean Lakes Association. Spent time with Phil and learned how to test the water with help from IU. Adding the data into the IU database. Now we will have more data to back up what we want to do with the lake. Team of volunteers in place to test the water.
- On Monday, 6/4, meeting at 9CT/10ET, with DNR. Rep will take an audit of the seawalls. Rod will be helping with where seawalls are located to know where to put glacier rock. Nate Thomas will help us to write grants (80% is funded by grants)
- Great progress on getting engagement from Indiana and Purdue University.
- Another part of this is educating the homeowners.
- The IN Clean Lake website has a lot of information and high quality of content.
- Bass Lake does not have its own designated DNR. But will be adding a new rep. Don't have a time of starting. Resource is still in training which is about 16 weeks.

### Bass Lake Conservancy District

- Rain report. 4.53 inches.
- Right at normal.
- When are we going to start the pump? From the BLCD, don't' want to turn it on until it goes up over the weir. The old weir would leach out 14 inches below top.
- They are authorizing Tom to turn on pump 6/4/18. Run 5 days to clear it out. Thinking it will need to stay on.
- Aquatic control identified 20 acres of milfoil control. DNR is only going to do 0.5 acre at the launch. If your prop chops up the weed, it is just going to spread it. The more activity on the lake, the faster it grows. Campaigning for more eradiation. Russ will renew his position. For all of Boa Shores area, need someone in a position for a year and then next year it will be a 4-year position. BLCD meets once a month on the 3rd Monday of month.
- When all the weeds were killed by the area referred to as "hillbilly beach", they don't disintegrate and end up floating in the water as sticks.
- Aquatic control is hired to monitor the lake. Phragmites are also very invasive along the shoreline. BLCD would like to have it eradicated. We use a grant to pay for it.
- The lake is cloudy. A lot is going on regarding what is causing this. The lake is not dead. We have had a seismic event that opened springs and it is bringing stuff up from the bottom of the lake. Boats and jet skis are churning up the water. It is getting better. Seems to be cyclical. Water is testing fine. Look at sulfates which can contribute to the foaming.
- Fishing is pretty good for walleye and crappie this year.
- Clarity improved from 3 inches to 12 inches by Rick Anderson's house.
- Not going to be doing weekly E coli testing. Elected to do once a month because only had one issue
