### IV. Legislative

Bill Oliver noted that nothing new is going on with the potential pier permits. He shared that Tom Busch attends the local Planning and Commissioner meetings, and Tom stated nothing will happen this year.

# V. Neighborhood Watch

Ron Vendl shared that the Crime Mapper Report on the Starke County website is still not working. He shared that due to recent storms there are quite a few trees down and none have done any real damage. The historical tree on 625 and CR210 did come down.

# VI. Building Maintenance

Ron Vendl stated that McGrath performed the spring maintenance on the air conditioning units. The blue room steel door replacement project is on hold until we know what will happen with the three furnaces that need to be replaced.

### VII. Rentals

Terry Chmiel stated both rooms are available for rent. Most of the recent calls have been for the fall. You can call the general number or his personal number in the front of the directory.

#### VIII. Social Committee

Cathy Wagner stated that unfortunately we need to cancel the annual pizza party on May 17<sup>th</sup>. The plan for the annual soup social is moving forward for October.

#### IX. Bass Lake Conservancy District

Larry Collura shared that we had 2.27 inches of rain in April and YTD 8.10. In April the pump added 32 million gallons and YTD 74 million gallons have been added. The BLCD will begin working with Aquatic Control to spray for weed control. The water needs to be 55 degrees to be effective.

Larry asked for those returning from the winter to check for any sink holes in the area Surf ran fiber cable. Should you see anything please call the Conservancy office with the details.

### X. Park Board

Tom Busch shared the water has been turned on at the campground however it is not yet on at the beach area due to the ongoing construction. The revitalization project is moving ahead and once completed will make for a great beach area. The beach area is still closed due to the construction equipment. The piers are installed but they ask people to wait until mid-May to move their shore station and boats in.

Tom stated the Park Board held their first grand opening for a kayak launch at English Lake. The Park Board thanks all those that have contributed to making the project a success (650W and Toto Road).

#### XI. New/On-Going Business

#### Prairie Trails Club

Russ Blais stated May 24 there will be a 3K run/walk on the trail. They are speaking to the Park Superintendent to see if they can tie it in with the opening of the beach, but nothing has been finalized yet. He shared there are two big areas that need to be repaired on the trail. Grant money is for new projects, so they are trying to raise funds to fix these areas. It should also be shared that there is a new sign by Scoops restaurant directing you to the trail.

#### DNR Boating Certification Class

Terry Chmiel shared that we will be hosting a DNR certification course on June 14 from 9:00 AM – 3:00 PM and a complimentary lunch will be served.
