## President Rick Anderson's Thoughts

February had rain, rain, & rain. How much? Enough to set a Bass Lake Conservancy District (CD) February rain record of 7.16 inches. That amount raised a low lake to up and over the dam. It also caused much area flooding and pointed out a Bass Lake sewer/treatment system problem. Problem, what problem? \$298,355.00; as #7 became a \$50 goner. The "Jackpot" again climbed while many lively conversations were taking place at the "V". Debates were about Bass Lake water quality, golf carts and Starke County stuff. Interestingly, there were many positive stories about residents pitching in to help their neighbors who had flooding issues.

The 6 inches of ice present on February 10 - what about that? Almost immediately following the February 27 Park Board meeting weather warmed and the ice quickly, I mean really quickly, vanished along with the "ice circles". Due to very active lake springs? Could be. What about a 3rd party operating the Beach Pavilion? That topic will certainly again be on the April 10 Park Board agenda.

Travelling to the March 3 Property Owners meeting, empty boat trailers were seen parked at the public launch/ dam waiting for their boats to return. I don't have a fishing report. However, fish activity close to shore is visible through clearer water. Water clarity has improved some. The DNR still plans to stock the lake with bluegill. Property Owners meeting discussions again included formation of a Healthy Shoreline Initiative Committee. The focus of the group would be lake improvement and fishing. Things like obtaining grant money for shoreline glacial stone would be one goal. Establishing this committee will be high on the agenda list of the April 7 meeting. Piers? The March 3 weekend witnessed pier pile unstacking and subsequent section installations. The 2018 season, like many season before it has begun!

Anything else from the March 3 PO meeting? A buoy order was finalized for new and replacement buoys. The damaged "Golf Carts - Next Two Miles" sign by the POB was replaced. The sign by the Pub remains. Sheriff Bill Dulin told me that until further notice, his Department will not be issuing tickets for golf cart use on the Bass Lake section of State Road 10 unless there is a traffic type violation. The 7.16 inch problem: Our CD Sanitary system flow increased eight times above normal. Could be several illegal sump pump connections. Could be some ground water infiltration. Bad flow metering seems unlikely. A system inspection is planned for this spring & summer; violations found carry a \$1,500.00 fine following legal resolutions. Can you believe illegal connections? My advice: Disconnect now & remain unknown. Lastly, the most monthly rainfall in CD records was August 2016 at 11.82 inches; the least was November 2012 at only .39 inches. Stay Safe & Healthy, Rick

#### Hop Aboard the Easter Train

The Easter Train on Saturday, March 31st, departs from the Hoosier Valley Railroad Museum in North Judson. Passengers ride in vintage cabooses, a passenger coach, or open-air sightseeing cars. The train excursion is round-trip from the depot and travels about five miles, crossing the Kankakee River at English Lake, before returning to North Judson. The train then continues on to a park along the railroad tracks where passengers disembark for an Easter Egg Hunt and a visit with the Easter Bunny. Each child and youth will receive a bag of toys and candy from the Easter Bunny. Afterwards, everyone will board the train for the trip back to the depot. Trains depart at 10:00 am, 12:30 pm, and 2:30 pm (central time). The total length of each trip, including the Easter Egg Hunt, will be approximately 1 hour and 15 minutes. Ticket prices are \$15.00 (adults, 16 and above), \$13.00 (youth, ages 6 - 15) and \$9.00 (children, ages 1 - 5). Groups of 6 or more get \$2 off each ticket. The completed golf cart permit (downloaded from their website listed below, also on the Bass Lake Property Owners website); a copy of proof of liability insurance for the golf cart; and the annual fee of \$25.00 – cash or check made out to "Starke County". Starke County passed and adopted an ordinance that governs the operation of golf carts. # WOODLAWN HOTEL

The Woodlawn Hotel was located at the corner of CR 625 E. and CR 210 at Bass Lake's north end. It was originally built as the Chittick House in 1887. According to Mrs. Ruth Cox, a doctor in Frankfort, IN gave her grandfather James Chittick only a year to live. He loved Bass Lake, so at the age of 38 he decided to move to the lake and spend his last year fishing and relaxing. Later James recalled there were only five families living right on the lake when he moved there in 1887. He and his wife Matilda built a small cottage at first. But soon they had to add on to accommodate their many friends. Over the years the small house grew into the hotel we see in this photo. Despite his doctor's prognosis, James lived to the age of 90. He attributed his longevity to the healthful living at Bass Lake.

The Chitticks decided to retire from the hotel business in 1926 and sold the hotel to the Shoemakers. They ran it many more years as the Woodlawn Hotel. It may have been the last hotel at Bass Lake from a bygone era when it closed in the late 1950's. Part of the former hotel was operated as a bakery for another 20 years or so before the old hotel burned down in the 1970's. This bakery housed the first Fingerhut presence on Bass Lake and a picture of it will be featured next month. *Ron Vendl, Starke County Historical Society*
