President Rick Anderson's Thoughts

The new season! The lake has clear water spilling over the dam and the ice is gone. I remain concerned that this season, many a jet ski will become tangled in and captured by intake clogging weeds. Pier after pier is leaving shore. One thing that is pretty universal when it comes to Bass Lake piers - they are not repaired in the fall. Reasons: Should have fixed it before we stacked it, let the winter do what it will, its too cold; its too hot; we're all too hungry and thirsty; whatever. The real reason of course is: When the pier is "back in", an assessment can easily be made of what material is required for repairs; how many new boards are needed? how many deck screws? how many patio block to repair the grass where the pier had been stacked? and just how much of whatever is needed? Then a quick trip to Johnson's Lumber and you're set. You might say Hi to Jerry and his crew too. Hold it; this year could be different! There are a couple signs out front: Lumber yard closed March 31. "Total Lumberyard Liquidation " auction April 13th. So is there a lumberyard future? There's talk, there's a chance that it may be purchased as a lumberyard and be reopened. Many people hope that. Johnson's Lumber has been at its location on US 35 since it was moved from Toto in about 1970.

The April 6 Property Owners Meeting: The board reviewed a garbage collection extension and voluntary curbside recycling contract from Republic Services. A motion was made, seconded and approved to accept. Currently we have 113 property owners who have committed to the 5 year curbside contract. The "Year One" cost will be \$108 and more are expected to follow suit and sign up. Larry Collura gave a presentation on our new website - many improvements. Rik Ritzler notified the group that the triangle changes at East CR 210 & 600 South will begin April 22 and should be complete before Memorial Day. The road will be closed for some days; however, when complete we will have a safer roadway. A safety cross walk is also being added on South CR 210 at the Boa Shores crosswalk. The 4th Annual "A Taste of Bass Lake Pizza" - a committee was formed for the May 18 event - cost will again be \$5 with advance payment - \$10 at the door. Over at our sewage treatment plant, muskrats have been doing some damage; the Conservancy District may need a trapper. Speeding around the lake remains a concern. This may require a committee to come up with recommendations for the Sherriff's Department. Maybe Neighborhood Watch can be involved. The "Great American Game" is back at the VFW. "Linco" AKA: "One Way" is also back after recovering from some medical issues. I have missed his and my Buddy Roger's political discussions and analysis. Anyway, the Jackpot is over \$160K and unless they win, many hope it will grow. I hope the weeds don't. A grant for 40 acres of milfoil control was approved by the state. This will need final state approval before any treatment can begin. Stay Safe & Healthy, Rick

In cooperation with the Starke County Highway Dept. we would like to encourage everyone to participate in the "Beautify Bass Lake" program the weekend of May 18 and 19. We are asking that you pick up debris in front of and along the road by your property that has collected during the winter. Please note that this does NOT replace your normal garbage pick-up and is devoted to roadside trash only; no tree, leaf, or weed debris, or hazardous products. The black trash bag is to be identified with a yellow plastic tie ribbon and is available for pick up with your 2019 membership supplies at the BLPOA building, on May 18th. Garbage and Recycling Contract Renewal—Over 100 enthusiastic Property Owners have signed up for Republic Services curbside recycling which begins on July 1 at an annual cost of \$108. The 5-year garbage collection contract extension as well as 5-year curbside recycling contract was passed at the April 6 Property Owners Meeting. For those who do not want curbside recycling, the Starke County Environmental Management District manages the county recycling. The new Recycling Site is just west of the County Highway Department. The site is open Monday—Friday from 7:00 a.m.—3:00 p.m. The location of the site is 3835 E. 250 N., Knox.

Note that as part of our lake garbage collection contract, Republic Services will take one large item per month such as furniture, mattresses, etc. Additional items can be picked up with special arrangement by calling the dispatcher at (574) 842-4719.

Avoid Fertilizers with Phosphorus—The chemicals you use on your lawn impact the quality of our lake water. Follow this basic guideline to help us keep our lake waters healthy. If you choose to use fertilizer, use slow-release nitrogen fertilizer that will be better for your lawn and the lake. A fertilizer with no phosphorus means that the middle number on the fertilizer package listing the nutrient ratio, nitrogen: phosphorus: potassium is 0. Questions? Sewer System Plugged Up— We have had problems with customers putting items in the sewer system that plug the pumps. Please DO NOT flush anything but toilet paper and human waste. Items such as cleaning wipes, toweling material, and feminine items do not break down before reaching the pumping stations. They clog the pumps and can cause serious damage. Bass Lake History — Spoor School



The Round Lake area was one of the first areas settled by early pioneers in Starke County in the late 1840's. In the early 1850's, a log cabin school was erected on William C. Spoor's farm about a mile north-west of Round Lake. Today this would be on CR 400 S about a half mile east of Range Rd. That first school was built of round unhewn logs. The seats and desks were made of rough split logs. A stone and mud fireplace provided heat.

This photo is dated 1914 and shows the fourth Spoor School, which was built in 1911. It was located at the south-east

corner of CR 400 S and CR 100 E. The teacher is Grover Short. Some of the children are Florence, Ada and John McFarland; Dave and Berl Spoor; other children may have included the Davis, Hansen, Miller, Short and Collins families. The school was used until 1930, when all the one room schools in California Twp. (Bass Station, Benton Grove, Maple Grove, Spoor and White) were consolidated.
